PROPERTY TAX INFORMATION

All Green County Property Tax Bills are available online from the Green County website. Receipts, copies or reprints of your property tax bill/s can be accessed on line. Follow instructions below.

1. Go To: <http://www.co.green.wi.gov/>
2. Click on Land Records System on the right of the page. A new browser window will open.
3. Type in the last name, then click on "Find Now".
4. Click on the Parcel # of the parcel you want to view.
5. The next screen will show the owner, address, etc. In the center of the screen, change the drop down from "Select Detail" to "Taxes"
6. Just below this section, you should see the "Print tax bill" and list of years. If you click on the year, it will open the property tax bill for that year in a new browser window. You can then save or print a PDF copy of that tax bill.
7. Just below this section, you should see a list of "Tax History" with a list of years down the left side. To get a receipt for a particular tax year, click on the year down the left, it will open a pop-up window. Then click on "Printer Friendly" and this will open in a new browser window. Then you can save or print a PDF copy of the receipt.

Making your payment

CHECKS PAYABLE TO TOWN OF ADAMS

1. Mail Payment via US Postal Service


Before December 31, 2018 send to: Adams Town Treasurer, PO Box 424, Argyle, WI 53504
Receipt request - There is no longer a need to include a SASE with your payment or to request a paper copy receipt of your payment. All receipts can be obtained online from the Green County website. (See above instructions.)

All payments with a postmark date of 12/31/2018 will be posted in 2018.

All payments with a postmark of 1/1/2019-1/31/2019 will be posted in 2019.

After 1/31/2019, all payments or second installments must be mailed to:

3. Walk-in Tax collections only at the Adams Town Hall

Saturday, December 29th, 2018 9a – 1p and Saturday, January 26th, 2019 9a – 1p

Hand delivered payments are only accepted at the Town Hall on the dates above.

All other payments need to be mailed to: Town of Adams Treasurer, PO Box 424, Argyle, WI 53504

Two party escrow checks need to be endorsed by the taxpayer/s. Escrow checks in excess of taxes owed will be accepted and the balance refunded to the taxpayer mailed out after the monthly board meeting. (Meets the second Monday of each month at 8 p.) Most efficient communication is via email at adamstowntreasurer@gmail.com if you have questions.

DON'T FORGET TO LICENSE YOUR PET DOGS!

Mail a separate check payable to the Town of Adams Treasurer PO Box 424, Argyle, WI a copy of the rabies vaccination for each dog you are licensing and a SASE. Information needed:

- ✓ Your current phone number and address
- ✓ Name, breed and age of dog
- ✓ Vaccination manufacturer
- ✓ Date vaccination was given
- ✓ Date vaccination expires

2019 License Fees: (May be purchased all year) see above instructions.

Male/Female	\$10 ea.
Spayed/Neutered	\$ 5 ea.
Multi-dogs (4-12 dogs – Kennel)	\$35
