SAMPLE OF AN AUTHORIZING RESOLUTION

Municipality Code 23-002

This sample resolution is a model for the authorizing resolution required of all responsible units. The resolution will authorize the representative to file the recycling grant application for the responsible unit. The representative must be an official or employee of the responsible unit. Please see page 4 of the recycling grant application instructions for additional information.

RESOLUTION

WHEREAS, Town of Adams (responsible unit) hereby requests financial assistance under s. 159.23, Wis. Stats., and Chapter NR 542, Wis. Adm. Code, for the purpose of planning, constructing or operating a recycling program with one or more components specified in s. 159.11(2)(a) to (h), Wis. Stats.,

THEREFORE, BE IT RESOLVED, that Town of Adams (responsible unit) HEREBY AUTHORIZES Township Clerk (authorized representative), an official or employe of the responsible unit, to act on its behalf to:

Submit an application to the Department of Natural Resources for financial assistance under s. 159.23, Wis. Stats., and Chapter NR 542, Wis. Adm. Code;

Sign necessary documents; and

Submit a final report.
